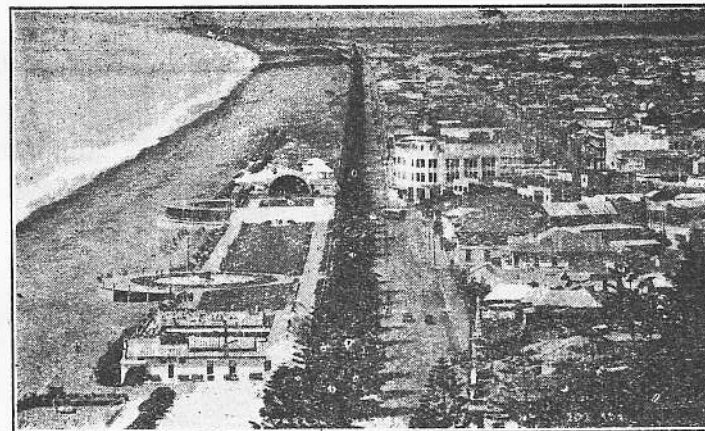

## CONDITIONS OF PLAY:

- 1.—All matches will be played under the rules of the N.Z.T.T. Association.
- 2.—The Barna 3 Crown ball will be used.
- 3.—Players must wear dark clothing in all matches; tennis shoes must be worn. The Committee reserves the right to scratch any player who does not conform to these requirements.
- 4.—The Committee reserves the right to seed the draw.
- 5.—All "A" grade matches to be the best of five (5) advantage sets excepting ladies' doubles and mixed doubles.  
All "B" grade and under 16 grade matches to be the best of three (3) advantage sets.
- 6.—The referee's decision in any dispute on a point of law is final. The decision of the umpire on a point of fact is final.
- 7.—The Tournament Manager and Referee is:  
Mr. E. Marriot.
- 8.—Matches commence at 6.30 p.m. each night. The Committee reserves the right to scratch any player who arrives late.
- 9.—Competitors must report to the official in charge on arrival each night.
- 10.—Entries must reach the Hon. Secretary not later than Tuesday, September 2nd, 1952.
