## Conditions of Play

1. All matches will be played under the rules of the New Zealand Table Tennis Association (Inc.).
2. Villa Balls will be used for all matches.
3. **DRESS:** Players must wear dark clothing in all matches; tennis shoes must be worn. The Tournament Manager reserves the right to scratch any player who does not conform with these requirements.
4. The Draw will be seeded.
5. All Open Championship events shall be the best of five advantage games of 21 up. All Junior and other events shall be the best of three advantage games of 21 up.
6. Play shall be continuous from the first service until the match be concluded, provided that when necessitated by circumstances not within the control of the players, the Umpire may suspend play for such period as he may consider necessary. Play shall never be suspended for the purpose of allowing a player to recover his strength or his wind. The Umpire shall be the sole judge of intentional delay, and after giving a warning, he may disqualify the offender.
- 6a. The "Pushing Play" time limit regulations of 20 minutes per game will be enforced.
7. The Referee's decision in any dispute on a point of law is final. The decision of the Umpire on a point of fact is final.
8. The Tournament is under the control of the Tournament Manager, Mr. Harry Jones.
9. Matches commence at 9.30 a.m. sharp. Play will be continuous from 9.30 to 5.30 p.m. The Tournament Manager reserves the right to scratch any player who arrives late.
10. Competitors must report to the official in charge on arrival each day.
11. Entries ACCOMPANIED BY FEES, must reach the Secretary, Mr. Harry Jones, P.O. Box 858, Palmerston North, by 5 p.m. on SATURDAY, 14th SEPTEMBER. Late entries will not be accepted. Entrants for Junior Events must have their age certificate properly attested.
